Agenda Item No. 01:- Confirmation of the Minutes of the 99<sup>th</sup>

Agenda Item No. 02:- Approval of list of services required for Authorized  
Operations – M/s. Jewelex India Pvt. Ltd. Unit-III

Decision:- The proposal was deferred as representative of the unit did not attend  
the meeting.

Agenda Item No. 03:- Approval of list of services required for Authorized  
Operations – M/s. United Jewellery Mfg. Pvt. Ltd.

Decision:- After deliberation, the Committee approved the Internet  
Telecommunication, Management or Business Consultant & Photography Service  
(for Jewellery Products).



**Agenda Item No. 04:- Application for Renewal of LOA - M/s. Lily Jewellery Pvt. Ltd.**

Decision:- After deliberation, the Committee deferred the proposal and directed the unit to settle the outstanding labour issues of the employee's.

**Agenda Item No. 05:- CRA objection pertaining to M/s. Sidd's Jewels Pvt. Ltd regarding capacity enhancement**

Decision:- After deliberation, the Committee regularized the excess production from 240000 Pcs to 589053 Pcs made by the unit during the year 2009-10 to 2013-14 considering their export & NFE during 2009-10 to 2013-14 & also noted that there was no DTA sale.

The Committee has also directed to issue a caution letter to the unit.

**Agenda Item No. 06:- Application for capacity enhancement - M/s. Shrenuj & Co. Ltd. Unit-I**

Decision:- After deliberation, the Committee approved the enhancement of capacity from 1,75,000 (Pcs) to 2,75,000 (Pcs) during the 2013-14 to 2017-18.

**Agenda Item No. 07:- Application for third party repair - M/s. Sunflower Jewellery Pvt. Ltd.**

Decision:- After deliberation, the Committee approved the details of import of jewellery for remaking of third party viz., Brass Studded Jewellery 4000 Pcs annually, in accordance with MOC & I Instruction No. 51 dt. 25.03.2010.

**Agenda Item No. 08:- Application for monitoring of performance of the unit- M/s. Systsoft Systems & Software Pvt. Ltd.**

Decision:- After deliberation, the Committee noted that the unit has achieved NFE of Rs. 501.03 lakhs during the period from 2010-11 to 2014-15 on cumulative basis in terms of Rule 54 of SEZ, Rule 2006 subject to softex verification by S.O.





**Agenda Item No. 09:- CRA objection pertaining to M/s. Neogem India Ltd.**  
**for non execution of Bond Cum LUT**

Decision:- After deliberation, the Committee, has noted the existing provision of SEZ Rule 22 (4) (b) provides that the value of the BLUT shall be equal to the amount of effective duties, leviable on import or procurement from the DTA of the projected requirement of capital goods, raw materials, spares, consumables, intermediates, components parts, packing materials for three month as applicable. Further, Rule 22 (1) (iv) (c) stipulates that where the value of BLUT executed falls short on account of requirement of additional goods, the unit or the developer shall submit additional BLUT. Rule 22 (1) (iv) (d) further states that there shall be no debit and credit and BLUT amount shall be monitored quarterly or yearly on the basis of QPR and APR submitted by the unit or developer and in any case of shortfall in the BLUT amount, a fresh or additional BLUT shall be furnished.

Therefore, Committee observed that the provision contained in Rule 22 (4) (b), Rule 22 (1) (iv) (c) & Rule 22 (1) (iv) (d) should be strictly adhered to and CRA may be replied accordingly.
