

SHORT TENDER NOTICE

The SEEPZ Authority invites Sealed Tenders for disposal of non hazardous solid waste for a period of one month i.e. July 2014.

- 1) The tender documents can be obtained either from the on any working day between 11.00AM to 3.00 PM. Manager (Estate), SEEPZ SEZ Authority, SEEPZ Service Centre Bldg., SEEPZ SEZ, Andheri (East), Mumbai - 400 096 or can be down loaded from the website www.seepz.gov.in. The Tender should be submitted in sealed envelope duly subscribed "Tender for disposal of non hazardous solid waste for the month of **July**, 2014".
- 2) The Bidder will have to pay an Earnest Money Deposit of Rs 2,00,000/- (Rupees Two Lakh only)) in the form of Demand Draft/Bankers Cheque in favour of **SEEPZ-SEZ Authority Fund** payable at **Mumbai** which is to be submitted at the time of tender in a separate envelope bearing the name of the bidder and marked 'security deposit'. **Bids without the earnest money deposit shall be treated as void and will not be considered for opening.**
- 3) The same will be refunded without any interest to successful bidder only after satisfactory execution of the contract and fulfillment of all contractual obligations.
- 4) The successful bidder shall to pay 50 % of the bid amount within the period of 2days on finalizing the tender & the balance 50% of the bid amount to be paid within period of 7days.
- 5) Earnest Money Deposit shall be forfeited if the successful bidder refuses or neglects or fails to comply with the conditions of the tender or withdraws his bid during the Tender period.
- 6) The bid is valid only for one month i.e. from 01st July, 2014 till 31st July, 2014.

- 7) Daily 2 labour will be permitted to depute onsite and segregation would be done under the supervision of caretaker.
- 8) The successful bidder would not be permitted to enter in various units for collection purpose. If any person found, than the contract would get terminate immediately and all deposit amount would be forfeited.
- 9) The last date for receiving the quotations is till 03:30 P.M. on 4th July, 2014.
- 10) The Tender will be opened in the Conference Hall of Development Commissioner Office on 04.07.2014 at 03:30 P.M. in the presence of Tenderers / their representatives, who may like to be present before the Tender Committee and other Officers so authorized.
- 11) The approx. quantity of one month's accumulation of the non hazardous solid waste is likely to be 90 tonnes , which may consist of the following:-
 - a) Metal scrap
 - b) Wooden Scrap
 - c) Corrugated Box
 - d) Plastic
 - e) Waste Paper mix
 - f) Thermocol
 - g) Glass
 - h) Any other misc. Items
- 12) The disposal is to be effected twice in a week, on every Wednesday & Friday from the designated dumping place. However, bidder will not be allowed to visit any unit or any other place in SEEPZ.
- 13) The loading of the scrap will be video graphed under the Supervision of SEEPZ Security and Caretaker.
- 14) The successful bidder should comply with all applicable laws, rules regulations and notifications prescribed by the Government of Maharashtra and Local Bodies from time to time and will give an undertaking to that effect.

15) It will be the sole discretion of the Authority either to accept or to reject any or all the tenders without assigning any reason whatsoever and the decision shall be final and binding on the bidder (s).
