Agenda Item No.1: Confirmation of the Minutes of the 14th Meeting held on

The Minutes were confirmed.

Budget for the year 2012-13

The Authority noted the budget for 2012-13. However, it will be discussed in the next meeting.

II. Extension of tenure of Chartered Accountant for 2012-13

It was noted that the proposal is for extending the tenure of Chartered Accountant for 2012-13 i.e. upto 31.03.2013. The Authority directed that it may be ascertained from the Local Office of CAG in writing as to whether there is any specific tenure limit prescribed for internal Auditors, which would be relevant for taking a decision in respect of the proposal

Decision: Authority deferred the proposal.

III. Extension of tenure of Official language Consultant

It was noted that so far no clarification has been received from the Ministry in response to the reference made seeking clarification as to whether the DC as HOD can approve appointment of Consultant or the same would require Ministry's approval.

Decision: Pending receipt of clarification from the Ministry, the Authority approved continuation upto 30.09.2012.

IV. Extension of tenure of Electrical Supervisor

It was noted that the services of Electrical Supervisor is required for further period as the existing staff of the Electrical Section in the Establishment of Dy. Engineer, MIDC at SEEPZ-SEZ is inadequate considering the vast area of the Zone Complex.

Decision: The Authority approved continuation of the existing arrangement upto

V. Enhancement in the expenditure for running the Creche facility.

It was noted that the Stree Mukti Sanghatana, which is running the Creche facility, has requested for enhancement of charges from Rs. 87,500/- to Rs.1,20,000/- per quarter considering the need for one more full time Caretaker as the number of children has reached 20.

The Authority noted that as per the practice that, the liability for providing Creche facility rests with the employer and therefore, it is necessary that the operating expenses are fully recovered from the employers.

Decision: The Authority approved the proposal for enhancement of quarterly operating expenses from Rs.87,000/- to Rs.1,20,000/- w.e.f. 01.04.2012. It was further directed to take appropriate steps for recovery of expenses. Units may be asked for payment of their contribution so that the expenditure incurred is fully reimbursed.

VI. The old Portuguese Church in SEEPZ-SEZ.

The Authority noted that as per the letter dated 8.10 2004 of the Ministry of Commerce & Industry in the matter, the entry to the church is to be permitted every Sunday. However, due to shortage of Security Personnel and considering that there is no separate compound wall around the church area and that the church is part of the existing SEEPZ area, the Zone Administration has been permitting annual Mass in the 2nd week of May every year. It was noted that St. John the Evangelist Church, Marol has vide their letter dated 20.5.2012 requested to hand over the church premises to them to have regular services in the church. It was also noted that the Christian community has been making this request through their representatives who called on the Development Commissioner from time to time. Also INTACH & ASI have not shown interest despite repeated letters.

Decision: After detailed discussion on the subject, the Authority decided as follows:-

- 1. A reference to be made to Ministry seeking approval for de-notification of the Church area. After de-notification, the SEEPZ SEZ Authority shall surrender the area back to MIDC for further necessary action.
- 2. After approval of the de-notification of church area by BOA, the MIDC to be asked to submit estimate for providing a gate near Indian Coffee House/M/s. Jewelex Ltd. for facilitating movement of vehicle / people of units located on the other side of the Church.

Estimate for providing Modular Toilet blocks at various location in

The Authority noted that the proposal is for providing Mobile Toilet block at 5 locations at a total estimated cost of Rs.59.41 lakhs. It was noted that the proposal has been submitted as at present there is no toilet facility provided for the floating population viz. Drivers, Vendors and Visitors.

Decision: The Authority directed that initially one regular toilet block may be constructed in vicinity of CGI/Renaissance/Multi-storied building of the internal Main road from where the employees mainly board the Contract buses. The location can be identified by a Committee comprising JDC/DDC/ADC(MJK)/Dy. Engineer, MIDC and two representatives (one from SEEMA and one from SG&JMA). The MIDC can submit estimate for construction of the regular toilet block (for Male/Female), which may be submitted in the next meeting of the Authority. The proposal in its present form was deferred.

Estimate for operation and comprehensive maintenance of lifts of

It was noted that the work of AMC of 16 lifts and providing services of Liftmen, have been assigned to the MIDC based on their revised estimate, as per which the total cost works out to Rs.47.21 lakhs as against to Rs.70.41 lakhs estimated earlier.

Decision: The Authority ratified the decision.

IX. Proposal for payment of incentive in the form of fee to the Officers/Staff attending to Authority's work.

It was noted that the Cochin SEZ has granted incentive in the form of fee which is paid on the monthly basis to the staff and officers dealing with the work of Authority. It was also noted that the work of the Authority envisages certain additional work for which no compensation has been considered so far. It was also noted that the Cochin SEZ has granted incentive in the form of monthly fee to the Officers and staff dealing with the work of the Authority and the proposal is for grant of similar fee to the Officers and staff of SEEPZ SEZ Authority. This issue was considered in the 10th Meeting of the Authority and the decision was to examine the matter further with reference to the relevant Rules. The matter was again considered by the Authority in its 12th Meeting held on 30.8.2011 wherein the decision was not to consider the proposal.

It was brought to the notice of the Authority that apart from CSEZ, some of the other SEZs have also granted incentive in the form of monthly fee.

Decision: It was directed that details of the fee granted in other SEZs may be obtained and the same may be submitted for consideration of the Authority in its next meeting. The proposal was deferred.

X. Refinery

It was noted that the need for setting up of a common refinery facility is considered necessary as the existing refinery facility of most of the G&J Units are not complying with the appropriate safety standard and there were instances of fire break out from the refinery of some of the units due to one reason or the other. It was further noted that the proposal of M/s. Hoover & Strong envisages setting up of a refinery and a unit for manufacture and export of Gem & Jewellery items and/or trading activity. The representative of M/s. Hoover & Strong had visited SEEPZ-SEZ and had held preliminary discussion with the Gem & Jewellery Association office bearers/ some of the Jewellery units and there were also joint meetings held in the Office of Development Commissioner, SEEPZ wherein the units were not very keen to use the proposed common refining facility. The issue of setting up of refinery were discussed in the Authority meetings held on 22.7.2009, 8.9.2009, 4.12.2009, 5.5.2010, 21.7.2010, 28.10.2010 and 10.2.2012. However, no final view was taken in the matter.

Subsequent to the proposal of M/s. Hoover & Strong, M/s. Diamond India Ltd., M/s. Asopec and M/s. C. Mahendra informed that they are also interested in setting up refinery.

Decision: After detailed discussion on the subject, the Authority observed that as the land for setting up the refinery is to be leased for 30 years, the following action in the matter to be taken:-

- Approval of BOA to be sought for setting up of refinery as an authorized operation for providing infrastructural facility to units.
- 2. In case proposal is approved by BOA, the technical and financial details of proposal for setting up a refinery needs to be worked out.
- 3. Thereafter, Expression of Interest to be called for after following due procedures.

XI. Additional sanction sought by the MIDC in respect of Special Repairs to SDF I & SDF II

The Executive Engineer, MIDC explained that the need for additional work arose due to the requirement of replacing the broken tiles staircases, additional painting work granite flooring, ACP cladding at entrances required, etc. The Joint Development Commissioner observed that in the letter dated 19.4.2012 of the MIDC, it has been stated "during repairs and restoration work at staircase the ceramic tiles provided along the walls of staircase has been damaged due to continuous joint in the tiles. The same has been brought to the notice of Hon'ble Jt. Development Commissioner during the visit at SDF-II."

Decision: The Authority directed that a Committee comprising JDC/DDC/ADC (MJK), Executive Engineer, MIDC and two representatives from each of the SDFs under consideration to visit the buildings and submit a report which can be considered in the next meeting of the Authority. The proposal was deferred.

XII: Creation of single window facility at Ground floor of Service Centre Building at SEEPZ-SEZ premises.

It was noted that the proposal is for providing proper working place for various Government Agencies and Labour Section on the ground floor. It was observed that the repair of Auditorium may be further examined vis-a vis the need for office space for day-to-day working.

Decision: The Authority approved estimate of Rs.85,14,850/- for providing the

- (i) Reception Counter
- (ii) Counter for initial scrutiny of documents.
- (iii)SEZ online helpdesk and kiosk
- (iv)Office space for various government agencies and service providers.

XIII: Extension of tenure of Service of Accounts Clerk.

It was noted that the existing tenure is approved upto 31.7 2012 and the proposal is for continuation of the same upto 31.3.2013. It was observed that it may be ascertained from the office of lhe CAG as to whether any tenure limit has been prescribed for the internal Auditor, which would be relevant as the Data Entry Operator is provided by the Chartered Accountant firm M/s. Kedia & Company.

Decision: The Authority approved continuation of the arrangement upto 30.9.2012 to be reviewed thereafter.

XIV: Outsourcing of Helpers and 2 Data Entry Operators.

It was noted that the proposal is for continuation of the outsourcing arrangement of 14 helpers and 2 Data Entry Operators with effect from 01.08.2012. It was observed that there is need for increasing the outsourcing charges in line with the Minimum Wages revision by State Government.

Decision: The Authority directed that the details with regard to revision of Minimum Wages to be worked out and submitted in the next meeting of the Authority. In the meanwhile Authority approved continuation of the existing arrangement upto 30.9.2012.

The following pending issues were also discussed:-

1. Disaster Management Plan

The Authority directed that the present status of implementation to be submitted in the next meeting of the Authority.

2. Occupational Health Centre

The Authority directed that a Committee constituted as per the minutes of the Special Meeting of the Authority held on 26.5.2011 to meet soon and the Committee's observation with regard to the functioning of the Health Centre be submitted in the next meeting of the Authority.

3. Policy for allotment of new space and surrendered space

The Authority directed that a Committee constituted to expedite its report, which may be submitted in the next meeting of the Authority.

4. Revision of Transfer Charges

The Authority directed that a Committee constituted to expedite its report, which may be submitted in the next meeting of the Authority.

The meeting ended with a vote of thanks to the Chair.

I. Budget for the Year 2012-13: - The Budget estimate for 2012-13 were discussed in the 15th meeting of the Authority held on 06.06.2012 and the same was deferred for further discussion. During the meeting, it was observed that certain works which are of capital nature shown under Schedule 'C' of Annexure I need to be shown under Annexure IV where capital works have been separately listed. This rectification has been carried out.

The Budget estimates are submitted for consideration of the Authority.

was discussed in the last meeting of the Authority held on 06.06.2012 and it was directed to ascertain in writing from the office of CAG as to whether there is any specific tenure limit specified for internal auditors. In this regard, it may be stated that as per Rule 6 (1) (iii) of the Authority Rules, the function of Chartered Accountant is "Maintenance and Finalization of Accounts". This would mean that he is not functioning as Internal Auditor. However, we have recently written to the Local office of CAG, seeking information.

The proposal is for continuation of tenor of existing Chartered Accountant Firm for the period upto 31.03.2013. Currently, Audit of the Accounts of the Authority by the CAG Auditors, for the year 2009-10 and 2010-11 is in progress. It would, therefore be necessary that the existing Chartered Accountant is continued for furnishing requisite clarification during the Audit and also for compliance of their suggestions. We have been paying for the services of the chartered Accountant @ 3.60 Lakhs p.a. for the year 2011-12. The CA has vide his letter dated 23.02.2012 (copy attached as Annexure A) for enhancement of the charges to Rs. 4.50 Lakhs p.a.

The proposal is submitted for consideration of the Authority.

Extension of tenure of service of Accounts Clerk: - The proposal for continuation of the tenure of service of the Accounts Clerk was discussed in the Authority meeting held on 06.06.2012 and it was observed that it may be ascertained from the local office of the CAG as to whether any tenure limit has been prescribed for the Internal Auditor. In this regard, it may be stated that as per Rule 6 (1) (iii) of the Authority Rules, the function of Chartered Accountant is "Maintenance and Finalization of Accounts". This would mean that he is not functioning as Internal Auditor. In the last Authority meeting, approval was granted for the continuation of the arrangement upto 30.09.2012 to be reviewed thereafter. The Outsourcing of services for maintaining the accounts is essentially required for which we have outsourced the services of Accounts Clerk @ Rs. 13,000/- p.m. w.e.f. August 2011. The CA firm has vide their letter dated 16.08.2012 (copy attached as Annexure B) requested for enhancement of the charges to Rs. 15,000/- p.m.

The proposal is submitted for consideration of the Authority

comprising JDC/DDC/ADC (MJK), Executive Engineer, MIDC and two representative from each SDFs under consideration to visit the buildings and submit a report which can be considered in the next meeting of Authority.

The Committee visited the SDF I & II buildings on 25.07.2012 and has submitted report recommending the above mentioned additional work. In view of this, it is proposed that enhancement in the expenditure for Special Repairs may be approved as follows:

VII. Scope of the work includes preparation of preliminary concept drawing for development of Green space.

VIII. Strengthening and repairing of over ground water storage tanks of SDF's and Gems and Jewellery Buildings and Service Centre Building in SEEPZ-SEZ:
The MIDC has vide their communication dated 09.08.2012 (copy attached as Annexure - D) stated that the ground water storage tank in the SDF and Gems & Jewellery Complex Building and Service Centre Building need to be strengthening to reduce water losses. It is stated that there in that the estimated expenditure for this works is Rs. 77,56,900/- inclusive of 15% ETP charges.

Submitted for consideration of the Authority.

Engineer, MIDC vide letter dated 08.08.2012 (copy attached as Annexure – E) has stated that as on 31.07.2012, an excess amount of Rs.2,35,38,810/- has been incurred by the MIDC and requested for release and amount of Rs.3.00 Crores from the Authority fund. The expenditure statement as on 31.07.2012 received from the MIDC indicates actual expenditure incurred of Rs. 235.39 lacs. A copy of the same is attached as Annexure – F. It is proposed to that we may release an amount of Rs. 3.00 Crores to the MIDC.

Outsourcing of Legal Services: - In the 12th meeting of the Authority held on 30.08.2011, the proposal of appointment of Legal Consultant was considered and it was approved to taking the services from Legal Counsel from Shri. Ashokan as per the specific charges mentioned in his letter dt. 30.05.11 for a period of one year

With regards to HSG, there is no eligible official in the feeder grade as all the 4 posts of SSG are vacant. As regards the Security Guards, we have obtained the list of the candidates from the Employment Exchange and are in the process of issuing letters for interview for selection. The Authority has approved outsourcing of 54 Security Guards and 6 Supervisors, out of which only 35 persons have so far been deployed. Though we have tried with several agencies, none of them has been able to provide the full strength. It is therefore proposed that Security Officer/staff those who superannuated in the preceeding 3 years and interested in giving their services, can be considered as an interim arrangement till regular postings are made. The proposal is to obtain in principle approval for the same, so that a written communication could be issued to all those security personnel who super annuated during preceeding 3 years period.

The matter of comprehensive planning for landscaping and maintenance of green in SEEPZ SEZ has been under discussion with MIDC since last 2 ½ years In the year 2009 I was told by CEO, MIDC, that they are looking for specialised agency for a comprehensive development and maintenance of SEEPZ as green. This apparently did not materialise because cost turned out to be too high. In the meantime, we have developed some parcels of greens in collaboration with the individual units. Some cleaning of space has been done which can be converted into Green Space, a large garden around the lake has been developed and some beautification by greening near the gates has been done. The agency which looks after the garden in SEEPZ has never been adequate in the task and recently their contract has also come to an end. The recent bio-diversity report shows an enormous variety of plants among other things in SEEPZ SEZ but they are neither nurtured nor trimmed leaving the entire care to the force of nature. It is, therefore, necessary that we invite a proposal for landscaping and maintenance and creation of garden space in SEEPZ SEZ from specialised agencies. While the final work need to be tendered with MIDC's technical guidance our primary search should be for a professional agency who will give a concept of design and plan. The work can be tendered after the best concept among the concepts received is approved by the SEEPZ Excerpts of the note can be sent to MIDC so that an appropriate newspaper advertisement for selection of an agency for giving "Concept and Design for landscaping, creation and maintenance of Green Space in SEEPZ SEZ by end of May, 2011.

Strengthening and repairing of over ground water storage tanks of S.D.F.'s and Gems and Jewellery Buildings and Service Centre Building in SEEPZ SEZ.

The maintenance of water supply scheme in SEEPZ - SEZ is being looked after by MIDC. The water is being purchased from MCGM at one point and further its storage is done at underground storage tanks and same is pumped to over head water tanks and thereafter distributed to consumers. There are eight underground tanks.

There are 10% to 15% losses in water supply scheme, which need to be reduced. The water storage underground tanks are inspected and water leakages are observed through underground storage tanks through the floor slab and walls of tanks. This results water losses in system upto 15% and there by revenue losses of about Rs. 8.00 to 10.00 lakhs per month.

The underground water storage tanks are not provided any treatment or strengthening since their construction. It is therefore necessary to provide repairing, waterproofing and strengthening of the said storage tanks so as to arrest water leakages and reduce the water losses and revenue losses in system.

Therefore this office has prepared an estimate amounting to Rs. 77,56,900.00 (G) including 15% E T P charges. The same is submitted herewith for favour of information and according approval to the same.


