Representations	Action Taken
<p>1. Shri Sanjay Lad — M/s. EOS Power Ltd.</p> <p>Shri Sanjay Lad raised the issues regarding payment from SEZ unit to EOU unit through ICEGATE not being raised in the IDPMS & EDPMS system.</p> <ol style="list-style-type: none"> 1. Unit purchased goods from EOU unit M/s. Fine Line based in Gujrat in USD. Earlier in NSDL system, the Payment of Bill of entry raised was reflected in IDPMS & EDPMS. 2. After the ICEGATE implementation in September 2024, DTA Bill of Export was filed for procurement from EOU unit. The payment module for SEZ to EOU unit is not yet active in ICEGATE. In this regard, Letter from M/s. EOS Power Pvt. Ltd. to Development Commissioner was sent. 3. When SEZ unit tries to do the payment, it is not being updated in the IDPMS & EDPMS of the seller. 4. Also, unit is procuring goods from MSME hence the payment should be done within the 45 days of procurement otherwise the unit has to face the penalty. 	<p>Chairperson directed the SO, SEEPZ SEZ to examine the issue and make necessary arrangements to resolve the issue.</p> <p>SO, SEEPZ, SEZ informed that the issue is already flagged in the ICEGATE.</p> <p>Accordingly, it was decided that a DO letter from the DC office will be issued to DG systems. Also, permission through e-office has to be processed for the NSDL special permission to units with all the relevant correspondences with ICEGATE & DG systems from customs department, SEEPZ, SEZ.</p>
