

Applications are invited from willing and eligible candidates for filling up vacant Customs posts on deputation basis in the O/o Development Commissioner, Falta Special Economic Zone. Description of the posts and eligibility conditions are as under:

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department in the Central Government shall ordinarily not exceed 3(three) years subject to satisfactory performance. The maximum age for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application. The terms of deputation will be regulated in accordance with the standard nimbA-4505/(5)6

terms and conditions prescribed by the Department of Personnel & Training, Government of India vide their OM No.6/8/2009-Estt(Pay-II) dated 17.06.2010 as amended from time to time. Officers selected upon will be eligible for deputation duty allowance as per Rules in force. Officials who volunteer for the post will not be permitted to withdraw their names later.

3. The bio-data (as per Annexure-I) duly supported by documents will be assessed by the Selection Committee while selecting candidates for appointment to the concerned post(s). The Development Commissioner, Falta SEZ reserves the right to modify and/or withdraw the vacancy circular at any time without assigning any reasons.

4.
