This occasion provides us the right opportunity to show our solidarity with the Armed Forces and their dependents, by contributing generously to AFFDF. All developers and unit holders under the jurisdiction of the O/o the Zonal Development Commissioner, SEEPZ are hereby requested to connect with the cause of war- widows, ESM, wards of the martyred soldiers and contribute generously to AFFDF in solidarity with our soldiers and their Next of Kin or dependents. Contributions to AFFDF are exempt from Income Tax under Section 80G(5)(vi) of the Income Tax. Act, 1961.

Payments may be made to Kendriya Sainik Board Secretariat, New Delhi by A/c Payee Cheque/DD drawn in favour of the 'Armed Forces Flag Day Fund A/c' payable at New Delhi or deposited directly in the Saving Bank A/c No.3083000100179875 maintained at the Punjab National Bank at R.K. Puram, New Delhi (IFSC Code: PUNB0308300) or online at www.ksb.gov.in.
