Dear Exporter,

This refers to the enclosed vide <u>Notification GSR No. 771 (E) dated 05.08.2016, Ministry of</u> <u>Commerce & Industry</u> which states that a valid RCMC issued by EPCES for SEZ units is mandatory/compulsory to avail the benefits of the SEZ Scheme under the SEZ Act 2005.

2. In view of the above, <u>M/s SEEPZ SEZ</u> has been marked for Non-Compliance of the Government requirement and policy condition of having a valid RCMC issued by EPCES. It is expected that the same will be done soon.

3. The procedure to obtain/renew RCMC is as follows:

(a) Members will have to login on the DGFT portal https://www.dgft.gov.in by clicking on the Login button with their IEC credentials.

(b) After logging in navigate to Service>e-RCMC>Apply for RCMC/Renewal of RCMC> click on 'Start fresh application'.

(c) Select the Export Promotion Council for EOUs & SEZ from the drop-down menu on RCMC Details page and complete the application form.

2. विशेष आर्थिक जोन नियम, 2006 में (जिसे इसमें इसके पश्चात मूल नियम कहा गया है) नियम 2 के, उप नियम (1) में खण्ड (य च) के पश्चात् निम्नलिखित खण्ड अन्तःस्थापित किया जाएगा, अर्थातुः

"(य छ) "रजिस्ट्री – सह – सदस्यता प्रमाणपत्र" से निर्यातोन्मुख यूनिटों और विशेष आर्थिक जोन को निर्यात संवर्धन परिषद द्वारा जारी किया गया सदस्यता प्रमाण पत्र अभिप्रेत है ।"।

3. मूल नियम में, नियम 22 के, उप–नियम (1) में खण्ड (iv) के पश्चात निम्नलिखित खण्ड अन्त∶स्थापित किया जाएगा, अर्थात :-

G.S.R. 771(E).—In exercise of the powers conferred by section 55 of the Special Economic Zones Act, 2005 (28 of 2005), the Central Government hereby makes the following rules further to amend the Special Economic Zones Rules, 2006, namely: -

1. Short title and commencement. -

- (1) These rules may be called the Special Economic Zones (Amendment) Rules, 2016.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Special Economic Zones Rules, 2006 (herein after referred to as the principal rules), in rule 2, in sub rule (1) after clause (zf), the following clause shall be inserted, namely: -

"(zg) "Registration-cum-Membership Certificate" means the membership certificate issued by Export Promotion Council for Export Oriented Units and Special Economic Zones.".

- 3. In the principal rules, in rule 22, in sub-rule (1), after clause (iv), the following clause shall be inserted, namely: -
 - "(v) The Unit or the developer including co-developer shall obtain a Registration-cum-Membership Certificate for availing exemptions, drawbacks and concessions.".

1. Introduction and Accessing DGFT Portal

DGFT has launched e-RCMC module as part of IT Revamp project to deliver seamless experience for the Importers and Exporters. This document will act as the user guide for Importer and Exporter working on the e-RCMC module available on <u>https://www.dgft.gov.in</u>.

Features of the current e-RCMC module are summarized as below:

- ✓ Soft Launch of Electronic Filing of Registration Cum Membership Certificate (RCMC) / Registration Certificate (RC) through the Common Digital Platform w.e.f. 6 December 2021 vide Trade Notice No. 27/2021-2022 Dated 30.11.2021.
- ✓ Transition Period of 3 Months i.e., up to Feb. 2022 or until further orders.
- ✓ Electronic (Paper less & contact less) and Real-Time Issuance of Certificate.
- ✓ Single Source of Information IEC Details are auto-authenticated and common across the Trade Ecosystem.
- ✓ CBDT and MCA Integration in-built in the System For PAN/DIN Details Auto-validation in Exporters IEC Profile.
- ✓ Auto-generation of Invoice by the System.

2. Registration-cum Membership Certificate

Registration-Cum-Membership Certificate (RCMC) is a certificate that validates an exporter dealing with products registered with an agency/ organization that are authorised by the Indian Government.

While applying for RCMC, an exporter ha sto declare his main line of business in the application. The exporter is required to obtain RCMC from the Council which is concerned with the product of his main line of business.

In case an export product is not covered by any Export promotion Council/Commodity Board etc., RCMC in respect thereof is to be obtained from FIFO. Further, in case of multi product is yet to be settled, the exporter has an option to obtain RCMC from Federation of Indian Exporters Organizaton (FIEO).

In respect of multi product exporters having their head office/registered office in the North Eastern States, RCMC may be obtained from Shellac & Forest Products Export promotion Council (except for the products looked after by APEDA, Spices Board and Tea Board).

In repect of exporters of handicrafts and handloom products from the State of Jammu & Kashmir, Director, Handicrafts, Government of Jammu & kashmir is authorised to issue Registration Cum Membership Certificate (RCMC).

It is issued for five financial years by the Export Promotion Councils (EPC's) / Commodity- Board / Development- Authority (or) other completed authority in India. These bodies function as the Registering Authority to issue the RCMC to its user. It is deemed to be valid from 1st April of the licensing year in which it was issued and shall be valid for 5 financial years ending 31st march of the licensing year, unless otherwise is specified.

2.1.Issuance of Registration-cum Membership Certificate

Applicant will register on DGFT Website <u>https://www.dgft.gov.in</u> as Importer/Exporter to access the Common Digital Platform.

Steps to apply for for Issuance of RCMC on the DGFT website are as follows.

1) Navigate to <u>https://www.dgft.gov.in</u>.



- 2) Click on Login button on top right corner of webpage.
- 3) Enter the User Name, Password and CAPTCHA Code and click on Login.
