Sub: Filling up of the Customs Posts

Applications are invited from willing and eligible candidates for filling up the following post by appointment on deputation in the office of the Development Commissioner, SEEPZ Special Economic Zone, Mumbai. The descriptions of the post and eligibility conditions are as follows:

(i) holding analogous posts on regular basis in the parent cadre or department. or, (ii) with six years' service in the grade rendered after appointment thereto on a regular basis in the scale of Rs. 4500-7000 pre-revised (Pay Band Rs. 5200-20200 and Grade Pay Rs. 2800) or equivalent in the parent cadre or department; and b. Possessing two years' experience in Excise or Customs procedural work.

As per DoPT's Clarification vide ID Note No. 1268489/2017-Estt. (Pay-II) dated 24.10.2017 a person in higher pay scale/grade pay on account of financial up-gradation under MACP/Non-Functional Up-gradation (NFU) or Non-Functional Selection Grade would become eligible for deputation to a post in the lower pay scale / grade pay of ex-cadre post equal to the pay scale/grade of his substantive post in his parent cadre. Further, in accordance with this Department's proposed guidelines on Deputation (Duty) Allowance, if the basic pay in the parent cadre has been upgraded on account of Non-Functional Up-gradation (NFU), MACP, NFSG etc., the upgraded basic pay under such up-gradations shall not be taken into account for the purpose of Deputation (Duty) Allowance.

(The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of application.)

2. Tenure of deputation normally is 3 (Three) years as per DOPT's guidelines.

3. The deputation rules, regulations and provisions as issued from time to time by DoPT shall be applicable. A Government Officer in a higher grade pay/scale shall be ineligible for appointment on deputation to a post in the lower grade pay / scale in terms of DOPT O.M. No. 6/8/2009-Estt (Pay II) dt.17.06.2010.

4. The officers selected will be entitled to transfer T.A and joining time in accordance with the Rules of the Government of India in force.

5. Application on proforma (Annexure-I) of eligible and willing officers who could be relieved in the event of selection along with following documents may be submitted through proper channel:

- a) Copy of APARs for the last five years duly attested by the competent authority,
- b) Vigilance clearance Certificate,
- c) Integrity Certificate,
- d) Details of penalty if any imposed during last 10 years any proceedings pending contemplated.

6. The application shall be considered only after receipt through proper channel.


7. Application found incomplete and in absence of above requirements will not be entertained.
