## Notice

SGJMA requested for deferment in Gatepass system “ऍवेश” implementation vide letter dated 27.09.2023. Accordingly, the Development Commissioner has approved following modification to Circular No. 31/20236 in light of the request made by SGJMA.

Para01 of the Circular may be read as-

*“In supersession of procedure set out in Circular No.04 dated 23.05.2017, following comprehensive guidelines /procedure will come into force w.e.f. 13<sup>th</sup> October, 2023 in order to implement new Gatepass system “ऍवेश” in a phased manner:*

*a. Units shall apply on or before 06<sup>th</sup> October, 2023 for all permanent Gatepass of employees and vehicles expiring by 30<sup>th</sup> September, 2023, accordingly, the passes expired between 05<sup>th</sup> September to 30<sup>th</sup> September will be valid till 12<sup>th</sup> October, 2023 and*

*b. All passes of exiting Gatepass system which are valid till 31<sup>st</sup> October, 2023 shall have to apply before 20<sup>th</sup> October, 2023 in new system “ऍवेश” and*

*c. All other permanent passes having validity beyond 31<sup>st</sup> October, 2023 in existing Gatepass system shall have to apply on or before 31<sup>st</sup> October and Old Passes will be discontinued after receiving the “ऍवेश” gate pass. Old Gatepasses with any validity will not be accepted after 30<sup>th</sup> November 2023 and the person will not be allowed to enter in SEEPZ, SEZ Premises.*

*d. Daily gate-pass will be issued by “ऍवेश” Gatepass system only from 13<sup>th</sup> October, 2023.*
