**Reason for Partial deletion and Revised Projections:**

The unit has stated that, considering long-term optimization objectives and administrative ease, they are planning to shift some of their business segments from EON SEZ to Magarpatta SEZ. As part of this, the unit wants to reduce one floor at **Cluster C, Wing 1, 2nd Floor**, which measures **29,675.54 sq. ft.** The employees currently on this floor will be relocated to the new SEZ unit at Magarpatta SEZ, for which they are in the process of filing a separate application.

Additionally, certain assets, mainly related to employees such as laptops, desktops, monitors, printers, accessories, and other IT equipment, will be transferred to Magarpatta SEZ on a bond-to-bond basis, following the inter-SEZ transfer process. Due to these changes, the unit has revised their projections for the remaining period of the LOA.
