**Amendment in the Allotment Rules 2015 for quarters.**

In partial amendment of the existing Allotment Rules 2015 for Accommodation in SEEPZ-SEZ Residential Complex, the Entitlement /Eligibility criteria for allotment of quarters, as approved in the 71st Authority meeting held on 04.02.2025, will be effective from 30/06/2023, as mentioned below:

Types of Accommodation	Entitlement/ Eligibility
D-2	Development Commissioner and any other Central Government officer not below the rank of Joint Secretary in the Central Government.
D-1	Joint Development Commissioner and any other Central Government officer of equivalent or higher rank.
C	Gazetted Officers of SEEPZ-SEZ and any other Central Government officer of equivalent or higher rank.
B	Non Gazetted Staff in SEEPZ-SEZ with Grade pay of Rs. 2400/- PM and any other Central Government employee of equivalent or higher rank.
A	Non Gazetted Staff in SEEPZ-SEZ with Grade pay of less than Rs. 2400/ PM and any other Central Government employee of equivalent or higher rank.
A & B	1. Outsourced staff either employed directly or through service provider. 2. Staff of Service provider, providing common facility in SEEPZ-SEZ, not under the employment of SEEPZ-SEZ.

- Note: 1. Priority shall be given to the govt officers/employees of SEEPZ- SEZ.  
2. All other terms & Conditions of the existing allotment rules 2015 remain unchanged.
