JNPA-SEZ area admeasure to 3000 sq. ft. at warehouse no. 6 in NSBP FTWZ Co-developer envisaging FOB value of Export Rs. 1250/- in Lakh, FE Outgo of Rs. 360.50/- in Lakh and NFE of Rs. 889.50/- in Lakh over a period of 5 years with employment generation of 12 employees.

Decision:- After deliberations, the Committee **approved** the proposal of M/s. JNPA-SEZ area admeasure to 500 sq. ft. at sector 4, Plot no. 406, warehouse no. 1 in NSBP Co-developer located at JNPA SEZ envisaging FOB value of Export Rs. 970/- in Lakh, FE Outgo of Rs. 701.50/- in Lakh and NFE of Rs. 268.50/- in Lakh over a period of 5 years with employment generation of 7 employees.

निर्णय:- विचार-विमर्श के बाद, समिति ने एसईजेड नियम, 2006 के नियम 17 और 18 के अनुसार मेसर्स जेएनपीए-एसईजेड में सक्रिय फार्मास्यूटिकल्स अवयवों की व्यापारिक गतिविधि को पूरा करने के लिए एक नई एफटीडब्ल्यूजेड इकाई की स्थापना के लिए मेसर्स संसुला इंटरनेशनल लिमिटेड देयता भागीदारी के प्रस्ताव को मंजूरी दे दी, बशर्ते कि व्यापारिक गतिविधि के लिए आवंटित सटीक स्थान को दर्शाने वाला मानचित्र प्रस्तुत किया जाए।

समिति को बताया गया कि इकाई ने शुरु में विनिर्माण और व्यापारिक गतिविधियों दोनों के लिए आवेदन किया था; हालाँकि, स्वीकृति पत्र (LoA) केवल विनिर्माण के लिए जारी किया गया था। इसके बाद, इकाई ने पहले से मौजूद क्षेत्र में व्यापारिक गतिविधि के लिए एक नई इकाई स्थापित करने के लिए आवेदन किया, बिना किसी पूर्व या उचित सीमांकन के। तदनुसार, 17.04.2025 को आयोजित अपनी बैठक में, अनुमोदन समिति ने इकाई को निर्देश दिया कि वह या तो मौजूदा इकाई को आवंटित क्षेत्र से अलग एक अलग क्षेत्र में व्यापारिक गतिविधि के लिए आवेदन करे, या यदि नई इकाई को उसी स्थान पर स्थापित किया जाना है, तो मौजूदा इकाई में क्षेत्र को हटाने के लिए आवेदन करे।

जेएनपीए एसईजेड के डेवलपर ने भी वीडियो कॉन्फ्रेंसिंग के माध्यम से बैठक में भाग लिया, जिसमें समिति ने क्षेत्र को हटाने के संबंध में एनओसी मांगी, जिसके बारे में डेवलपर ने पुष्टि की है कि उन्होंने पहले ही ऐसी इकाई को एक गतिविधि के लिए क्षेत्र को हटाने और शेष क्षेत्र को अन्य गतिविधि के लिए उपयोग करने के लिए एनओसी दे दी है।

Agenda Item No. 04:

Proposal of M/s. SG Pharma Global Pvt. Ltd for setting up a SEZ Unit for trading and export of various Pharmaceutical Drugs at M/s. JNPA-SEZ.

M/s. SG Pharma Global Pvt. Ltd has applied for setting up a New FTWZ Unit to carry out the Trading activity of various Pharmaceutical Drugs at M/s. JNPA-SEZ area admeasure to 250 sq. mtr at JNPA SEZ envisaging FOB value of Export Rs. 3855/- in Lakh, FE Outgo of Rs. 0/- in Lakh and NFE of Rs. 3855/- in Lakh over a period of 5 years with employment generation of 14 employees.

The committee was apprised that the unit initially applied for both manufacturing and trading activities; however, the Letter of Approval (LoA) was issued for manufacturing only. Subsequently, the unit applied to set up a new unit for trading activity in the pre-existing area without prior or proper demarcation of space. Accordingly, in its meeting held on 17.04.2025, the approval committee directed the unit to either apply for trading activity in a separate area, distinct from the area allotted to the existing unit, or apply for deletion of area in the existing unit if the new unit is to be set up in the same space.

Developer, JNPA SEZ has also attended the meeting through Video Conferencing wherein the committee asked for the NOC in respect of deletion of area of which it has been confirmed by the developer that they have previously given NOC to such unit for deletion of area for one activity and using the balance area for other activity.

वित्त वर्ष 2020-21 से 2023-24 के लिए वार्षिक निष्पादन रिपोर्ट विनिर्दिष्ट अधिकारी, जेएनपीए एसईजेड से इकाई द्वारा प्रस्तुत एपीआर के आधार पर प्राप्त हुई थी। विनिर्दिष्ट अधिकारी, जेएनपीए एसईजेड की रिपोर्ट में कहा गया है कि इकाई ने वित्त वर्ष 2023-24 के दौरान 122.90 करोड़ रुपये का सकारात्मक संचयी एनएफई हासिल किया है। हालांकि, इकाई ने पिछले वर्ष की अवधि के अंत में उल्लिखित एनएफई मूल्य को 90 लाख रुपये अधिक बताया है। इसलिए, वित्त वर्ष 2021-22 और 2022-23 के लिए एपीआर को संशोधित करने की आवश्यकता है।

निर्णय:- विचार-विमर्श के बाद समिति ने एसईजेड नियम, 2006 के नियम 54 के अनुसार मेसर्स कृष बेकर्स एंड कन्फेक्शनर्स प्राइवेट लिमिटेड के प्रदर्शन पर गौर किया और उल्लेखित वर्षों के लिए वार्षिक ब्याज दर (एपीआर) को संशोधित करने का निर्देश दिया।

Monitoring of the performance of M/s. Krish Bakers & Confectioners Private Limited for the period FY 2020-21 to 2023-24.

LoA No. SEEPZ-SEZ/NEWSEZ/JNPT-SEZ/KFI/01/ 2018-19 dated 22.05.2018

The Annual Performance Report for the FY 2020-21 to 2023-24 was received from Specified Officer, JNPA SEZ on the basis of APR submitted by the unit. The report of Specified Officer, JNPA SEZ stated that the unit has achieved positive cumulative NFE of Rs. 122.90/- Crore during the FY 2023-24. However, the unit has mentioned the NFE Value higher by Rs. 90 Lakhs at the end of Previous year period. Therefore, APR for the FY 2021-22 and 2022-23 needs to be revised.

Decision:- After deliberation, the Committee **noted** the performance of M/s. Krish Bakers & Confectioners Private Limited in terms of Rule 54 of SEZ Rules, 2006 and directed to revise the APR for the mentioned years.

The following are the reasons for the downward export projections despite the change in manufacturing items:

1. **Completion of Three Years of Operation:**

They have already completed **3 years** of operations and are now entering the **4th year**, with **1 quarter already completed**. Hence, the projections are revised only for the remaining **2 years**.

2. **First Year of Exports Limited to 5 Months:**

They began their operations in **November 2022**. Therefore, the **first year of exports** (April 2023 to March 2024) is limited to just **5 months** of export activity.

3. **Initial Low Exports Due to Market Conditions:**

Due to low market demand for the existing authorized operations, their **export performance** in the initial 3 years has been much lower than the projections previously approved by your esteemed office.

4. **Export Performance and Future Growth:**

In FY **2024-25**, they achieved exports of approximately **Rs. 267 Lakhs** from existing authorized operations. However, with the change in manufacturing items, they foresee a **substantial growth in exports**. They already have active enquiries from clients for these new items, and they expect exports to increase to **Rs. 1000 Lakhs** in FY **2025-26** and **Rs. 1200 Lakhs** in FY **2026-27**.

5. **Five-Year Block Comparison and Justification:**

While exports may appear reduced in the **5-year block comparison**, if they consider the balance of the remaining **2 years**, the revised projections show an increase in exports compared to the first 3 years.

Purpose of this transfer :

At present GPIBC has 800 doors at J MATA DEE FTWZ For operational efficiency they are looking to consolidate 400 doors out of these 800 doors and 16 returnable containers at their JNPA facility.

Operationally, this will reduce the administration of providing a re-export bond at two different zones. Instead, only a single re-export bond will be required at JNPA, Nhava Sheva Business Park Pvt Ltd. With this consolidation, it will help saving time, cost and manpower.

These returnable containers and doors will subsequently be delivered to a customer located in the Domestic Tariff Area. The customer will carry out the required Customs formalities under Customs Notification 104/94 dated 16th March 1994 including posting the bond and subsequently re-export these containers and deliver them to their consignees overseas. The returnable containers and doors in question are procured by SEZ unit on behalf of M/s. GOODPACK IBC SINGAPORE PTE LTD., which they want to transfer to JNPA (Nhava Sheva Business Park Pvt Ltd. Plot No 5-1, in Plot No 406 FTWZ1, SECTOR 4, JNPT SEZ, Village Sawarkhar, Taluka - Uran District Raigad 400707) for their authorized operation.
