- b. Subsequent revisions/rectifications, if required, in Tax Audit Report filed earlier, pertaining to the financial year under Audit, shall also be done by the appointed firm of auditors.
- c. Observations in the Draft Tax Audit Report should be discussed with the concerned Authority and important observations should be brought to their notice so that timely corrective action can be taken.

B. Audit Team

The team should consist of One Qualified Chartered Accountant and One Semi Qualified Article Assistant (who is pursuing Chartered Accountancy Course and are registered with ICAI), led by a senior partner of the firm.

The personnel/employee deployed shall have the required qualification and experience to complete the audit in timely and efficient manner.
