Service Centre, SEEPZ-SEZ, Mumbai - 400 096.

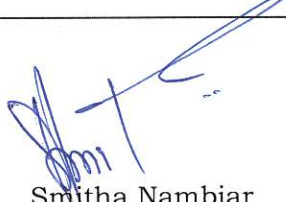

1. Representatives from Multistoried building. Water shortage at Multistoried buildings to units. Since last 1 year, almost Rs. 1 crore are spent on water tankers. No choice except tankers for the water.	- Development Commissioner directed the units to give it in writing to DC office. - Development Commissioner informed units that for multistoried building the pipeline will be separated & new extra pipeline will be provisioned. - The tender for separate pipeline is finalized. - Daily Reporting of water tanks in buildings to be systemized and the responsibility to be given building wise. One Caretaker and one representative per building shall jointly report daily.
2. M/s. Tuffropes Pvt. Ltd. Delay in APR submission of 9 months FY 2022-23 & Fy 2023-24.	Development Commissioner directed concerned ADC to levy the penalty for late APR submission for 7 months and regularize the APR submission.
3. Shri Bharat Mathur, CA, M/s. IPG Asia Pvt. Ltd. - Foreign Exchange Realization for 2023-24 was 4.47 crores but in 2024-25 it was null. No receipts was submitted. - Unit informed that in reply to SCN	Development Commissioner directed concerned ADC accept & regularized the APR.

Is registered in vendor database in INR currency and bill is generated default in INR.	• Development Commissioner informed that services are not allowed to sell in INR currency in domestic area. • Development Commissioner directed concerned ADC to levy the penalty of Rs. 10,000/-.

WNS. • Delay in APR submission of 162 days for FY 2023-24 for first unit and 66 months for FY 2023-24 for second unit. • Unit informed that they are unable to submit online APR from 2019-20. • Unit submitted they are following it up since 2019.	• Development Commissioner directed concerned ADC to levy the penalty for late APR submission for 5 months and regularize the APR submission for first unit. • Development Commissioner directed unit to send to DC office of all the applications they have sent for the challenges they have been facing since 2019. • Development Commissioner directed concerned ADC to levy the penalty for late APR submission for 26 months and regularize the APR submission for second unit.
