**Sub.- Seminar on “Pradhan Mantri Viksit Bharat Rozgar Yojana (PMVBRY)”
– regarding participation of SEZ Units and Associations – reg.**

Kind attention is invited to the communications received from the Ministry of Labour & Employment and the Department of Commerce, Government of India, regarding implementation of the Pradhan Mantri Viksit Bharat Rozgar Yojana (PMVBRY) a landmark Central Sector Scheme aimed at promoting employment generation, formalization of workforce and enhancement of social security, with a special focus on the manufacturing sector and SEZ-based employment.

The Employees' Provident Fund Organisation (EPFO) has been designated as the *implementing agency* for the scheme, and all establishments covered under the EPF & MP Act, 1952, including SEZ Units, are eligible for the benefits under the scheme.

In order to disseminate detailed information and facilitate awareness among SEZ stakeholders, a seminar / outreach session is being organized in coordination with EPFO (M/o Labour & Employment) as per the following schedule:

- Clarifications on implementation and data validation.
