(*) As per DoPT's Clarification vide ID Note No. 1268489/2017-Estt. (Pay-II) dated 24.10.2017 a person in higher pay scale/grade pay on account of financial up-gradation under MACP/Non-Functional Up-gradation (NFU) or Non-Functional Selection Grade would become eligible for deputation to a post in the lower pay scale / grade pay of ex-cadre post equal to the pay scale/grade of his substantive post in his parent cadre.
