Subject: Power Supply Provision for Phase Detection System at Gate No. 1 & Gate No. 3

This is to inform to all concerned that the work related to the provision of power supply for the Phase Detection Devices proposed to be installed at Gate No. 1 and Gate No. 3 is scheduled to be held between 29.11.2025 to 15.12.2025. The said work involves the construction of an underground raceway using aluminum pipes for safe and secure cable routing beneath the existing tiled surface.

Scope of Work:

The scope of work under this notice shall include, but is not limited to, the following activities:

- 1. Fabrication of Aluminum Square Pipes as per required specifications.
- 2. Dismantling of existing tiles carefully to avoid breakage.
- 3. Excavation of the tile bed for laying the aluminum pipe raceway.
- 4. Construction and installation of aluminum pipe raceway beneath the tiled flooring for cable passage.
- 5. Laying of electrical cables through the raceway for power supply to the phase detection system.
- 6. Restoration of tiles to their original position after completion of laying work.
- 7. Final finishing, levelling, and cleaning of the work area to restore it to its original condition.

You are hereby requested to submit your quotations in the prescribed format provided below. Please ensure that all quoted rates are inclusive of fabrication, dismantling, excavation, cable laying, restoration, and finishing.
