The trading activity for gold, silver, platinum, other precious metals, diamonds and other precious and semi-precious stones, shall be permitted only on an intra-SEZ basis, i.e., within SEEPZ only, and shall be subject to strict compliance with Instruction No. 100 dated 25.10.2019 issued by the Ministry of Commerce

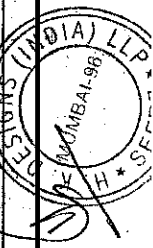

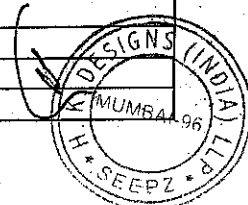

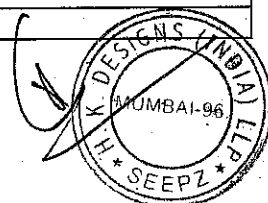

The condition no. xi of Instruction no. 117 issued by MoC&I, stipulates that DCs shall keep a strict watch on the high risk commodities such as areca nuts, betel nut, black pepper, dates etc. and may consider restricting dealing in such sensitive commodities by FTWZ units and warehousing units. **Moreover, the list may further be regularly reviewed by the Unit Approval Committee based on the risk perceptions of the various commodities.**

e. Recommendation:

The proposal containing the list of items and their ITC HS codes, submitted by the warehousing unit M/s. BVC Logistics Pvt. Ltd., SEEPZ-SEZ, in terms of Instruction No. 117 dated 24.09.2024, is placed before the Approval Meeting for review.
