3. The cupboard shutters are completely damaged and missing.
4. The kitchen cabinet shutters are totally damaged and not available.
5. The windows are completely damaged and not in usable condition.
6. The window frames are damaged and beyond repair.
7. The plumbing fittings are either non-functional or missing.
8. The plaster and paint are severely damaged.
