Observation

Clarification/Comments regarding LOI issued by Developer, Arshiya FTWZ (through RP) to M/s Swiftlog Shipping Services Private Limited, were sought from Co-developer namely M/s. Ascendas Panvel FTWZ Private Limited, to which they have responded as under:

"We, Ascendas Panvel FTWZ Private Limited, in our capacity as a Co-developer and the lessee of the warehouses, wish to state that we are not aware of any transaction or arrangement between Arshiya Limited (under CIRP) and Swiftlog Shipping Services Private Limited. We categorically object to the said transaction, as we have neither been informed nor consulted in this regard. Further, we are not aware whether any area under our possession, management, or control has been considered for the issuance of the aforesaid Letter of Intent (LOI).

In view of the above, we kindly request that no portion of the area under our possession, management, or control be included in, or considered for, any transaction or for the issuance of any Letter of Approval (LOA), until Arshiya Limited (under CIRP) obtains our prior written consent and explicit confirmation. We further request that this consideration be extended to all common areas i.e. Access Roads, Additional Lands, Common Area Infrastructure Facilities, HVAC Areas, and other shared spaces.

Without prejudice to the foregoing, we reserve all our rights in this matter."

In connection with above, vide email dated 24.11.2025 addressed to Shri Pankaj Mahajan, Resolution Professional, for the Developer namely M/s Arshiya Limited (under NCLT) was requested to furnish detailed comments on the issues raised, as referred to by M/s Ascendas Panvel FTWZ Pvt. Ltd., and to submit any other relevant facts or documents necessary for proper appraisal of the matter before placing it in the UAC, however, no reply has been received so far.
