निर्णयः निर्णयः- विस्तृत विचार-विमर्श के बाद, समिति ने माल के हस्तांतरण के प्रस्ताव को मंजूरी दे दी, अर्थात् होल्ड / टैंक सफाई रसायन, परीक्षण किट, और उपकरण आदि, बीओई संख्या 8922394 दिनांक 17.03.2025, बीओई संख्या 5003499 दिनांक 12.08.2024, और बीओई संख्या 1001289 दिनांक 24.05.2024 के तहत आयातित, मेसर्स सर्वेश्वर लॉजिस्टिक सर्विसेज प्राइवेट लिमिटेड, जेएनपीए एफटीडब्ल्यूजेड (आईएनपीजेएन 6), द्वारा उनके ग्राहक मेसर्स एपेक्स केमिकल्स (एस) प्रा। की ओर से, मेसर्स ओन्सिनेक्स वैर्चर्स प्राइवेट लिमिटेड, चेन्नई एफटीडब्ल्यूजेड (आईएनएनपीके 6) को। एपेक्स केमिकल्स (एस) प्रा. लि., एमओसीएंडआई निर्देश संख्या 117 दिनांक 24.09.2024 के संदर्भ में।

अनुमोदन समिति ने आगे निम्नलिखित निर्देश दिएः

- ii. इकाई माल के हस्तांतरण से संबंधित संपूर्ण लेनदेन का पूर्ण और सटीक रिकॉर्ड बनाए रखेगी।
- iii. माल की लोडिंग प्राथिकृत अधिकारी/निर्दिष्ट अधिकारी, जेएनपीए एसईजेड की भौतिक देखरेख में की जाएगी। अधिकारी यह सुनिश्चित करेंगे कि माल केवल जीआईएस-आधारित ट्रैकिंग प्रणाली से लैस जीपीएस-सक्षम वाहन में ही ले जाया जाए।
- iv. चेन्नई FTWZ में प्रवेश करने पर, माल को चालान/पैकिंग सूची के अनुसार सील, निशान और संख्याओं के सत्यापन के अधीन किया जाएगा, साथ ही गलत घोषणा या छिपाव की किसी भी संभावना को रोकने के लिए लॉट का यादृच्छिक निरीक्षण किया जाएगा।
- v. यूनिट को पूरे ट्रांसफर प्रोसेस के दौरान SEZ एक्ट, 2005, SEZ रूल्स, 2006, और सभी लागू कस्टम्स रेगुलेशन का सख्ती से पालन करना होगा।

Decision :- After detailed deliberation, the Committee approved the proposal for transfer of goods, viz. Onnsynex Ventures Private Limited, Chennai FTWZ (INNPK6), on behalf of M/s. Apex Chemicals (S) Pte Ltd., in terms of MoC&I Instruction No. 117 dated 24.09.2024.

The Approval Committee further directed as under:

- i. This permission is granted as a one-time measure based on the specific request of the unit, and shall not be treated as a precedent or general practice.
- ii. The unit shall maintain complete and accurate records of the entire transaction pertaining to the transfer of goods.
- iii. Loading of the goods shall be carried out under the physical supervision of the Authorized Officer/Specified Officer, JNPA SEZ. The officer shall ensure that the goods are transported only in a GPS-enabled vehicle equipped with a GIS-based tracking system.
- iv. Upon entry into Chennai FTWZ, the goods shall be subjected to verification of seal, marks and numbers, as per the Invoice/Packing List etc. along with random inspection of the lot to prevent any possibility of mis-declaration or concealment.
- v. The unit shall ensure strict adherence to the SEZ Act, 2005, SEZ Rules, 2006, and all applicable customs regulations during the entire transfer process.
