The mission is to maximize space utilization, facilitate ease of doing business and support industries like gems and jewellery, electronics and design-led manufacturing, thereby strengthening export capabilities.</p> <p>Major Area of Action:</p> <ol style="list-style-type: none"> i. Completion and operationalization of NEST-III and commencement of NEST-IV construction. ii. Digitization of internal approvals and unit compliance processes. iii. Fast-tracking infrastructure upgrades including energy-efficient utilities.

Complete the re-densification strategy including phased demolition of old structures and construction of NEST towers (III & IV), supported by enhanced common infrastructure (power, water, internet, etc.). ii. Attract global investors through policy stability, SEZ incentives, and proactive facilitation in electronics, semiconductors, and precision manufacturing sectors. iii. Implement integrated platforms for unit interaction, compliance tracking, and performance monitoring using AI and IoT-based systems. iv. Focus on green buildings, waste management systems, and solar energy integration to make SEEPZ-SEZ a model eco-friendly export zone. v. Rationalize procedures, reduce transaction time, and strengthen grievance redressal mechanisms to boost stakeholder confidence.
