Agenda Item No. 01: Confirmation of Minutes of the 69th Meeting held on 24.03.2026.

The Minutes of the 69th Meeting held on 24.03.2026 were confirmed with consensus.

एजेंडा मद सं. 02: मेसर्स ओन्साइनेक्स वेंचर्स प्राइवेट लिमिटेड द्वारा जेएनपीए एसईजेड में वस्तुओं के वेयरहाउसिंग एवं भंडारण तथा लॉजिस्टिक्स कार्यों हेतु एक नई इकाई स्थापित करने संबंधी प्रस्ताव।

मेसर्स ओन्साइनेक्स वेंचर्स प्राइवेट लिमिटेड ने जेएनपीए एसईजेड क्षेत्र में एनएसबीपी एफटीडब्ल्यूजेड सह-डेवलपर के वेयरहाउस नंबर 3 में 1000 वर्ग फुट क्षेत्रफल में वेयरहाउसिंग एवं भंडारण तथा लॉजिस्टिक्स गतिविधियों हेतु एक एफटीडब्ल्यूजेड इकाई स्थापित करने के लिए आवेदन किया है। इस प्रस्ताव में 5 वर्षों की अवधि में 200 लाख रुपये के एफओबी निर्यात मूल्य, 15 लाख रुपये का विदेशी मुद्रा व्यय तथा 185 लाख रुपये का एनएफई प्रस्तावित है, साथ ही 5 कर्मचारियों के रोजगार सृजन का भी प्रावधान है।

Agenda Item No. 02: Proposal of M/s. Onnsynex Ventures Private Limited for setting up of a new unit for warehousing and storage & Logistics of Items at JNPA SEZ.

M/s. Onnsynex Ventures Private Limited has applied for setting up a FTWZ Unit for Warehousing and storage & Logistics of Items at JNPA SEZ area admeasuring to 1000 sq. ft. at warehouse no. 3 in NSBP FTWZ Co-developer envisaging FOB value of Export Rs. 200/- in Lakh, FE Outgo of Rs. 15.00/- in Lakh and NFE of Rs. 185.00/- in Lakh over a period of 5 years with employment generation of 5 employees.

निर्णय: अनुमोदन समिति ने यह नोट किया कि यूनिट ने वेयरहाउस या स्टोर किए जाने वाले सामानों के लिए विस्तृत HSN कोड जमा नहीं किया है।

विचार-विमर्श के बाद, समिति ने निम्नलिखित शर्तों के अधीन प्रस्ताव को संलग्न नक्शा अनुसार मंजूरी दे दी:

1. वस्तु-वार एचएसएन कोड प्रस्तुत किया जाए।
2. इकाई को डीजीएफटी तथा वाणिज्य एवं उद्योग मंत्रालय द्वारा समय-समय पर जारी सभी प्रतिबंधों, दिशानिर्देशों एवं निर्देशों का पालन करना होगा, जो एसईजेड इकाइयों पर लागू होते हैं।
3. इकाई को उचित सावधानी बरतनी होगी तथा एसईजेड अधिनियम, 2005 एवं उसके अंतर्गत बनाए गए नियमों के तहत निर्धारित सभी शर्तों का पूर्ण अनुपालन सुनिश्चित करना होगा।
4. समिति ने निर्दिष्ट अधिकारी, जेएनपीए एसईजेड को परिसर का निरीक्षण करने तथा इस संबंध में अपनी रिपोर्ट प्रस्तुत करने का निर्देश दिया है।

एजेंडा मद सं. 03: मेसर्स न्हावा शेवा बिजनेस पार्क लिमिटेड द्वारा जेएनपीए स्थित एनएसबीपी -एफटीडब्ल्यूजेड में अपनी मौजूदा इकाई में 1,67,145.952 वर्ग मीटर क्षेत्रफल जोड़ने संबंधी प्रस्ताव।

इकाई ने अपने मौजूदा एसईजेड यूनिट, जो एनएसबीपी-एफटीडब्ल्यूजेड में स्थित है, में 1,67,145.952 वर्ग मीटर क्षेत्रफल जोड़ने हेतु आवेदन प्रस्तुत किया है। यह आवेदन बिना पूर्व में निर्धारित प्रक्षेपणों (प्रोजेक्शंस) में किसी संशोधन के किया गया है। साथ ही, इकाई ने अपने विद्यमान लेटर ऑफ अप्रूवल में शेष 5 वर्षों की अवधि के लिए ब्रॉड बैंडिंग के माध्यम से निर्माण वस्तुओं में परिवर्तन का भी प्रस्ताव किया है।

2. The unit shall adhere to and comply with all restrictions, guidelines, and instructions issued from time to time by the DGFT and the Ministry of Commerce & Industry, as applicable to SEZ units.
3. The unit shall exercise due diligence and ensure compliance with all conditions prescribed under the SEZ Act, 2005 and the rules framed thereunder.
4. Committee directed Specified Officer, JNPA SEZ to visit the premises and submit their report for the same.

निर्णय: विचार-विमर्श के बाद, समिति ने Nhava Sheva Business Park Ltd. के उस प्रस्ताव को मंजूरी दे दी, जिसमें NSBP-FTWZ JNPA में स्थित उनकी मौजूदा यूनिट में 1,67,145.952 वर्ग मीटर का क्षेत्र जोड़ने की बात कही गई थी।

Observation

It is observed that the Unit was granted LOA No. SEEPZ/NEWSEZ/JNPT-SEZ/SRSPPL/34/2022-23/21040 dated 09.12.2022 for carrying out **trading activity** over an area of 10,200 sq. mtrs. valid up to 08.12.2023.

Subsequently, M/s. SRS Pharmaceuticals applied for **deletion of 8,500 sq. mtrs. area** from the approved LoA for proposed manufacturing activity and to use balance 1700 Sq mtr for trading activity. The same was approved by approval committee and informed to unit vide letter dated 07.04.2025.

The proposal has now been submitted by the unit for setting up a new Manufacturing unit over the said deleted/diverted area of 8,500 Sq. Mtrs. at the same location.

Further, LoA No. SEEPZ/NEWSEZ/JNPT-SEZ/SRSPPL/34/2022-23/21040 of the unit for trading activity has expired on 08.12.2026.
