The above unit is on long term lease of **95 years** on renewal basis. The sub-lease agreement needs to be executed for the balance period i.e. **52 years** at present.



- Employment envisaged
- Any other criteria as may be deemed fit by the Authority
- Premium offered over and above reserve price
- In the case of existing SEEPZ unit, past track record including export performance of the existing unit.
