Sub: Issue of renewal of RCMC to EOUs/SEZs

Attention is invited to the Gazette Notification No. GSR 771 (E) dt. 05.08.2016 issued by Ministry of Commerce & Industry which stipulates that Registration-cum-Membership Certificate is to be issued by Export Promotion Council for Export Oriented & Special Economic Zones i.e. Units, Developers and Co-Developers.

Attention is also invited to the Public Notice no. 44/2015-20 dt. 05.11.2018 which stipulates that RCMC certificate is to be obtained by Units/Developers/Co-Developers for availing exemption, drawbacks and concessions from Export Promotion Council for EOUs and SEZs.

However, it is noticed that only some of the Units have registered for RCMC and most of the Units, Developers & Co-Developers are yet to register and ensure compliance as per the DGFT PN dt. 05.11.2018 read with Gazette Notification dt. 05.08.2016.

All the Unitholders/Developers/Co-Developers are hereby requested to obtain the Registration-cum-Membership Certificate for availing exemption, drawbacks and concessions from Export Promotion Council for EOUs and SEZs, within 15 days, failing which, import and export consignments may be withheld. Hence, Unitholders/Developers/Co-Developers may ensure timely compliance in terms of the Ministry's Notification no. GSR 771 (E) dt. 05.08.2016, so as not to hamper their day to day export activity.

The Specified Officers are also requested to contact and ensure that the unitholders/developers/co-developers under their jurisdiction register themselves and obtain the RCMC.
