In compliance to the Public Notice no. 04/2017 dated 30.01.2018 and continuation to the amended Public Notice no. 07/2020 dt.04.01.2021, the updated list of the additional valid empanelled agencies for disposal of E-Waste/lead acid batteries are annexed in addition to the vendors listed in Public Notice dt. 04.01.2021.

The list will be updated from time to time based on the receipt of applications if any with regard to authorized/approved Recyclers for disposal of the aforesaid waste and the aforesaid list will be valid for a period of one year or till the validity of the MPCB whichever is earlier.

Empanelled agencies will be handling the specific type of waste only for which, permission has been granted to them by the MPCB/CPCB.

All the empanelled vendors will be required to pay their yearly renewal/registration fee latest by 15th of the last month of the preceeding year of their expiry of Licence, so that registration may be renewed/registration for the next year.
