In compliance to the Public Notice no. 04/2017 dated 30.01.2018 issued by SEEPZ SEZ Authority for empanelment of Recyclers for disposal of E-Waste/lead acid batteries/sludge through septic tank/gutter waste containing non-toxic heavy metals, the empanelled agencies registered with Office of the Development Commissioner, SEEPZ SEZ will only be authorized to dispose off the E-Waste/lead acid batteries/sludge through septic tank/gutter waste containing non-toxic heavy metals from the Zone subject to the norms prescribed by the respective State/Union Territory and also subject to the validity of the MPCB/SPCB licence.

All the empanelled vendor will be required to pay their yearly renewal/registration fee latest by 15th of the last month of the preceeding year of their expiry of Licence, so that registration may be renewed/registration for the next year.
